### Nigger Says Black On White Racial Crime Should Not Be Reported

Miami, Florida - A nigger employed by the Miami Herald has published an editorial justifying the brutal murders of Channon Christian and Chris Newsome and stating that newspapers should not report black on white racial crime.

Leonard Pitts, a nigger employed by the Herald, said that those upset about the brutal rape of both white victims should "Cry me a river ... It always amazes me when white people put on the victim hat"

Christopher Newsome was sodomized by five black males who shouted racial slurs at him, before his penis was cut off, his body cut into parts and he was set on fire. Channon Christian was raped and sodomized, had her breast cut off while still alive, had bleach poured down her throat and into her orlfices while still alive, before her throat was cut.

Black racial activists in Knoxville have published articles justifying and celebrating the murders and calling on blacks in the area to commit additional crimes.

The bizarre position taken by Nigger Pitts is typical of the mentality fed into the semi-educated blacks, and self-hating whites produced by Jewish faculties at major universities. Such loathsome, ignorant creatures predominate in the Jewish owned media.

How To Pull A Media Stunt

There are folk out there who wonder how I manage to draw the media attention I have been able to draw consistently for the past eleven years or so.

I use a lot of tactics -- including hard work and organizing, and having a lot of money at my disposal -- but one my favorite tactics has always been "the stunt". "The stunt" is very effective because it will often draw the attention of millions of people, embarass your opponents, and lead to the distribution of tens if not hundreds of thousands of pieces of literature. When I was in the NSM, these would also bring in thousands of dollars and dozens of new members.

The essence of the stunt is to find something that someone powerful is trying to make high profile and then interject yourself into it, exploiting some weakness of your enemy, so as to draw all the

attention away from them and onto yourself. And this is not something I just do for kicks -- but I have also often done to draw attention away from people who have not been able to suffer it as well as I am.

To wit, the current Dossier Noir stunt, which has been a brilliant success:

1) I read that the Canadian government was cracking down on this little website, Dossier Noir, because it had opposed a group of niggers who had gang raped a white girl.

A number of things were immediately clear to me: a) The Canadian government was wrong; b) That the Jews were responsible, and would be incapable of defending their actions; c) That they were completely dependent on the lap-dog Jew media in Canada for cover on this; d) That the domain name dossier noir was now available and open for hijack; e) That it would greatly embarass them if I seized control of it.

So I saw the opportunity and I took it. I will tell you something readers -- seizing opportunities like this is what makes greatness. I wish more white activists had the courage to do it. It would make my job easier. ;-D

- 2) Once I took it I let the Canadian government have it. You see, I knew Dossier Noir was not a defensible position. Google would not stand up to the Canadian government forever -- after all, what interest did Google have in protecting the blog? So I didn't publish something that was "moderate" or "reasonable". Canada had already banned the "moderate" and "reasonable" weblog -- and committed an atrocity in doing so. So I seized the website and fought like a cornered tiger till they took me down. Since I knew I couldn't win there, I knew that there was nothing to lose by fighting -- just like, if I were Canadian, there would be nothing for me to lose by assassinating Richard Warman at this point. If you're going to go down, might as well take as many as you can with you.
- 3) I also shifted the terrain of the battle off of a territory which the enemy could win -- the dossiernoir.blogger.com website -- and onto a territory where I could crush them. You see, I've done many rounds

with Canada and its legal and military and intelligence authorities in the past -- and I know they can't touch Overthrow.com. I also know they can't have me "arrested" in their dreams.

So what I did is took them from a place where their ranting and raving could pay off -- taking down the initial Dossier Noir website -- and took them onto a terrain where their ranting and raving is impotent -- and makes them look weak -- the Overthrow.com website.

What I find amusing is that the Canadian press is now trying to spin the destruction of Dossier Noir as a "victory" for the Canucks -- so they can claim victory and retreat without touching Overthrow. They think this covers for them. Next week, next month, and next year, I will still be mocking them.

4) I also picked targets -- Richard Warman and Bernie Farber -- who have extremely thin skins, and who are prone to lying and exaggeration. No one actually threatened to murder Richard Warman -- but he has been running around saying that that's what's happening. The problem, though, is that anyone who comes to the website can see exactly what I'm saying -- and anyone can come to the website. All the Canadian television and radio have done is push people to my website.

There are 12.3 million households in Canada. 7.9 million of them have internet access, 79,000 of them have visited my website since yesterday. This means that 1% of the entire population of Canada has read my website in the past day and a half, one out of 50 Canadians will have read my call to arms against their government in a few days. Maybe one in ten will read it this month.

This means that more Canadians will read my website because of the thin-skinned-ness of Richard Warman than would have read it in an entire year otherwise.

Plus, Warman has now put the idea into the head of millions of Canadians that he should be killed -- along with Canada's entire Jewish population. That's worth something to. At the very least, it encourages the least stable members of society, who had been held back because they felt isolated in their desires, to act. Its called the





### Feeling Better

May 22nd, 2008

For the past few months I have been increasingly unwell.

In January, my wife became extremely ill with complications from her pregnancy. She developed pre-eclampsia, which turned into liver failure (HELLP Syndrome) and something like a stroke (eclampsia). Our daughter was delivered eleven weeks early at two pounds, nine ounces.

netime around the time the doctors informed me my wife and daughter were likely to die, and this is the first time in months I've even been able to write or say something like that without immediately breaking down into tears, something went wrong with me. I really can't explain what it was, but today is the first day I've even vaguely begun

I'm not naturally a very depressed person or someone given to extreme emotions. I can be confrontational and many people find me intimidating, but I am not someone naturally prone to violence or extreme anger or hatred. I don't a blacks and Jews, but I generally don't have much emotion associated with it. Its that lack of emotional content in views that makes me very difficult to dissuade — I'm one of those people for whom racism is a natural and althy state — one that is the result of feeling comfortable, not uncomfortable. Plus, in my day to day work, people come at me with knives or come at me swinging a two by four and I take it in stride. I see an angry mob, go into their midst, duke it out, and don't even break a sweat. I strangle a Negro crack dealer, take a few kicks to the head, and the next day I'm enjoying vacation. Things just roll off of me, and I really don't do well in very low-stress environments. While I don't bet lots of money, even on vacation I do things like drink lots of coffee and gamble at high stress games like black jack, where I count cards (and the counting just adds to the mental focus and stress level in the game). For fun I do logic puzzles and Sudoku, and read difficult works of philosophy. I thrive in intense and challenging environments.

So, you would think that when my daughter and wife survived the experience and ended up healthy, I would have recovered from this dead feeling, and things would have returned to normal, but they didn't. For the past few months, my daughter has really been the only thing that makes me smile, and even then, not really as much as she should. Things have become progressively worse, day by day, and I have woke up more and more often feeling the need to kill, kill, and have tried to get through my day while ignoring the need to destroy the wicked. Its not been easy.

The other week, my wife asked me if I had become "depressed" since the baby was born. I told her depressed people feel something. Several friends have described me as "morose". One joked the other day that they were worried I was about to "go Joseph Paul Franklin". They've been close.

Since my wife was hospitalized until today my feelings have ranged from completely dead to occassional outbursts of literally murderous anger. I've been going through my life doing the things I need to do, but I haven't been doing them the way I used to do them — they've all been half hearted and uncommitted — things I've been doing for form, not substance. Over the past few months, it has become impossible to live my life day to day. I've just been ignoring things; I haven't even opened much of my mail for months; it is piled up in bins in my living room. My taxes aren't done; I've put them aside. I have not been aggressively renting apartments; I've got more vacancies than I've 'most ever allowed myself to carry. I've just been ignoring things I don't like, avoiding things I don't want to see ... : become very dependent on the people who do the work for me, sometimes too dependent. My company has \_\_ifered substantially from this - not unrecoverably, though I've now decided I need to not recover the rental portion of it and let it go in favor of construction, but substantially. I'm like that guy in Office Space who woke up one morning and just decided he didn't want to go to work or pay any bills, but without the comfortable hypnosis.

Combined with this dead feeling I realized the other day that I have, almost without realizing it, though that may seem a bit strange, developed a very intricate plot for the murder of about a score of Roanoke City's Negro nuisances and their annoying counterparts at the Roanoke Times. I know everything about these assholes — where they live, who they live with, what they look like, where they go, when they go there. I estimate I could probably, in the course of a few hours, kill fifteen out of the twenty easy if I picked the right day and time, and still lived long enough to travel the country and begin picking off the ridiculous "independent journalists" that staff the Southern Poverty Law Center's Intelligence Report. I have a list of those as well. What's amazing is that I've been doing this almost without paying attention to it, until I started thinking about things the other day.

The other day I read something, as it happened, about post traumatic stress disorder. It was completely random, but something struck me when it mentioned dissociation. I was a psych major with biological and clinical foci at University of Maryland; I studied stuff like this. I realized that dissociate was an extremely good term for what I was doing. The other day I drew a gun and was ready to kill one of my tenants, based mostly on behavior from the tenant that while violent and disruptive, would usually have rolled off my back. As I've thought about things the past few days, I've realized that I've been avoiding confrontations solely to avoid killing people. As my list of people to kill has grown, it has become rather paralyzing.

Somewhat scary stuff, I guess. Not normal or healthy.

Today, I had something like a heart attack combined with an almost complete breakdown. I say something like a heart attack because I'm not trying to be Ha! Turner. I had a sharp pain in the left hand side of my chest, became "t headed, and had to sink to the ground to keep from falling. I had:

Chest discomfort with lightheadedness, fainting, sweating, nausea or shortness of breath.

- Increased or irregular heart rate.

Feeling of impending doom.

id not have:

- Uncomfortable pressure, fullness, squeezing or pain in the center of the chest lasting more than a few minutes.
- \* Pain spreading to the shoulders, neck or arms. The pain may be mild to intense. It may feel like pressure, tightness, burning, or heavy weight. It may be located in the chest, upper abdomen, neck, jaw, or inside the arms or shoulders.
- \* Paleness or pallor.

So I don't know what that is, but it wasn't pleasant. I've done some research, and it sounds like a whole bunch of other things that aren't heart attacks, but also aren't good, but are stress related.

In any case, after a brief near-faint I recovered and decided to pack up and leave work early. On the way home, I had some sort of breakdown and had to pull my car over into a parking lot for about twenty minutes. I just couldn't pull anything together. I couldn't even speak. It was not a normal experience for me.

I've never really had problems like this before and don't know what to make of them. In any case, it was unusual. I just felt like I collapsed. The whole thing is somewhat embarassing, frankly, and probably a little pathetic, too — maybe something I should keep off a blog, though I won't. But regardless, since then, I've felt a whole lot better. Things feel a whole lot clearer and I don't feel the detachment from things that has been hanging over me for months. I suddenly feel happy in the normal way I feel happy. I am no longer angry about all the people who spend their time screwing me over in small ways (and most of life and business, to me, is a series of small people trying to screw you over in small ways). I can talk about my wife's hospitalization without serious problems, which is something I couldn't even do this morning. I feel much more alive than I have recently. It is good.

still have a bunch of practical issues that need to be taken care of. I think I am going to force a closure of White mes and Land's rental business, take some time off, maybe take a vacation, keep the construction business, and jet back to work on what I enjoy — remodeling houses — instead of what I hate — babysitting "human beings" that are really little more than animals. A friend of mine pointed out the other day that you never meet an old property manager that loves life, and several friends of mine have pointed out that the day to day work of cleaning up houses is just demeaning for someone of my intelligence to be doing. I don't have that kind of class arrogance — I like going into a house that is totally destroyed and rebuilding it. I just don't like rebuilding the same house every two months on an emergency schedule because the latest bunch of white trash has pissed on the carpets — again. In fact, I had a friend call and say he'd never thought about how dried urine would have white crystals in it until he read my blog ...

Regardless, the rental business is over. Someone better than me will have to take over the properties, and I am going to file paperwork to force a sale sometime in the near future. We could continue operating, but I choose not to. The drain and strain on me is just no longer worth it, and if I'm going to feel better and take a vacation, its a lot easier to take a vacation from construction than from tenants.
